#### Recovery Act Reporting Preliminary Summary 2011 Quarter 2 February 17, 2009 through June 30, 2011 As of July 30, 2011

#### WHAT'S NEW THIS QUARTER

- Expenditures on Section 1512 (see Recovery Act Basics) increased by slightly over \$1 billion with most of this in expenditures reported by state agencies.
- Expenditures on Mandatory funds increased by about \$744 million.
- Award amounts decreased slightly, probably representing some reallocation of contracts and grants.
- The number of Jobs (as FTE's) declined about 2% as some contracts or grants reach or near completion.
- Of contracts awarded by federal agencies and grants awarded to or through state agencies, about three-quarters of funds have been expended.
- Of awards made directly to cities, counties or other sub-state organizations, slightly over half of the awarded funds have been expended.

#### **ABOUT THIS REPORT**

This report summarizes information submitted by organizations and entities in Florida related to funds provided by the American Recovery and Reinvestment Act (Recovery Act). This report covers the period through June 30, 2011 and is based on information submitted by organizations receiving Recovery Act funds as of July 30, 2011. This is the first preliminary release of data for the quarter. The federal web site (Recovery.gov) will release two additional preliminary updates and the final data for the quarter will be released on September 21, 2011.

The information in this report was compiled by Don Winstead. He was formerly the Special Advisor to Governor Charlie Crist for implementation of the Recovery Act. He now has a consulting firm in Tallahassee (Don Winstead Consulting, LLC). While these reports were compiled based on procedures and protocols developed while Don served as Special Advisor to the Governor, this report is not a government report and is provided solely for information as a service to the people of Florida.

#### SOME RECOVERY ACT BASICS:

- **Division A.** The Recovery Act has two major sections, called "divisions". <u>Division A</u> of the Recovery Act appropriates funds through federal agencies to states, cities, counties and other organizations. These appropriated funds may be in the form of grants, contracts or loans.
- Section 1512 of the Recovery Act is part of <u>Division A</u> and establishes new reporting requirements that all organizations receiving funds must meet to remain eligible for

funding. Information on these grants, contracts or loans is posted on the federal web site, Recovery.gov.

- **Division B.** <u>Division B</u> of the Recovery Act contained funding for federal <u>mandatory or</u> <u>entitlement programs</u> such as increased benefits for Unemployment Insurance, Supplemental Nutrition Assistance (Food Stamps), Medicaid, Temporary Assistance for Needy Families (TANF), etc. Because these benefits largely go directly to beneficiaries, there are no additional reporting requirements. Information on these funds is generally not included in the maps on the Recovery.gov web site. This information is included in the attached report to provide comprehensive information on the scope of Recovery Act funding. Data included in this report is compiled from various federal and state sources.
- **Cumulative vs. Quarter-Only.** The information on <u>awards and expenditures</u> is <u>cumulative</u> but the jobs information is for <u>the reporting quarter only</u>.
- **Prime Awards vs. Subawards**. Many Recovery Act grants or contracts include funds that are subgranted or subcontracted. Some information, such as Jobs (FTE) is reported only at the prime award level, while award information is reported at the prime recipient and also the subrecipient level. Most of the tables and charts in this document are compiled at the prime award level. The information in Table 8a and 8b, however, uses net subaward information to compile county-level reports.
- Jobs Information. Jobs information for the awards reported by <u>organizations receiving</u> <u>awards is based on a count of Full-Time Equivalent jobs (FTE). This is calculated by</u> reporting organizations based on the number of hours in the quarter worked in positions funded directly by Recovery Act awards. Information reported by the <u>Council of</u> <u>Economic Advisors</u> is based on broader estimates that include all Recovery Act funds.
- **County Totals**. Tables 8a and 8b include county-level data. The totals are based on net local amounts. For example, a company in a county may be funded by a prime award in another state or county. In addition, a portion of a grant to an organization in a county may be subgranted to an organization in a neighboring county. The amount shown would reflect the net amount awarded or subawarded. The state total exceeds the total of primary awards because Florida organizations receive subcontracts or subgrants from prime contracts or prime grants in other states.
- **Potential Reporting Errors.** The summary information posted on the federal website also includes a relatively small number of obvious reporting errors. The summary information included in the attached tables has been refined to exclude those reporting errors according to data analysis protocols that are explained in the technical addendum attached.







#### **Discussion of Table 6**

The White House Council of Economic Advisors (CEA) is required by section 1513 of the Recovery Act to report quarterly on the impact of Recovery Act funds on employment, estimated economic growth, and other key economic indicators. To date, CEA has published 7 quarterly reports.

In the first 6 quarterly reports, CEA published national employment estimates and included an appendix with state level estimates. In the 7<sup>th</sup> quarterly report, the state estimates were not included.

Past CEA estimates have included two methodologies. One is the 7<sup>th</sup> quarterly report included a table (Table 8, page 12) that summarized previous estimates from various sources. The figures summarized in Table are also shown in Table3 and Table 4 in the report. The CEA analysis includes estimated effects on employment using macroeconomic effects of fiscal policy (CEA Multiplier Model) and a statistical forecast comparing what happened with statistical estimates of what would have been forecast in the absence of the Recovery Act (Statistical Projection Approach). These estimates are shown above in the columns "CEA Model Approach" and "CEA Projection Approach". These represent point in time estimates based on the middle month of the quarter.

In comparing Table 8 from the 7<sup>th</sup> quarterly report to the information previously reported, the numbers do not always match up. It is possible that prior estimates have been revised, but the source of the inconsistency is not known.

In prior reports, there is a national estimate, which in recent reports has been based on the midpoint of the estimates from the Multiplier Model and the Statistical Projection Approach. The total used in previous reports is shown in the column labeled "All States." In recent prior reports, Florida's estimated employment impact has been approximately 5.45% of the national total.

Using this ratio, based on the national total shown in the 7<sup>th</sup> quarterly report, it is estimated that the employment impact from all Recovery Act funds in Florida for the 1<sup>st</sup> quarter of 2011 (January through March) was approximately 163,000 jobs.

The report for the March through June, 2011 quarter has not been published. Based on prior reports, this should be published by October 1, 2011.





In some cases, awards excluded as potential errors may be prior quarter awards where the current quarter award has not been submitted. When the current quarter submission is made, the awards will be counted in subsequent reports.

#### Technical Summary Obvious Reporting Errors

The Recovery Act reporting process was an extraordinary effort and represented significant progress in transparency. It was not, however, without its technical challenges. The reporting system used the "award number" as the key identifier. In the cumulative files used to display totals on the maps and charts on the Recovery.gov web site, awards (including contracts, grants and loans) are connected each reporting period through use of the award number. As long as the award number is used consistently, the system accurately reports the cumulative totals. If there was an error in the award number, no matter how slight, the matching process does not work and the cumulative reports showed the award amount multiple times.

The problem was hard to detect because there is no uniform method in the federal government for assigning award numbers. After this problem was identified, a procedure was developed to connect these reports, but the error is not always detected and the process does not always work. When an error is found that is older than the most recent quarter, the recipient cannot fix the problem and must rely on the federal agency to make the correction. Here is an example of how the problem develops.

In quarter 3, 2010 a city in Florida reported award number <u>FL-93-00</u> in the amount of \$15,805,000. In subsequent quarters, the same city reported award number <u>FL-93-03</u> in the amount of \$15,805,000. These appear to be the same award, yet both are included in the cumulative file. The maps for this county on Recovery.gov include 2 awards totaling \$31,610,000.

### To avoid overstating the totals in this report, awards containing this type of obvious reporting error have been excluded. This has been accomplished by the following data cleansing process:

- 1. Select prime awards where the Year and Quarter are not the current Year and Quarter.
- 2. Of these awards, select the awards where the Final Report indicator is NO.
- 3. Of these awards, select the awards where the Project Status indicator is Not Completed.

Without adjustment, the Recovery Act cumulative report would include <u>both</u> of the awards and overstated the amount awarded. <u>Through the adjustments made to the summaries in this</u> <u>report, the first erroneous report has been excluded and the \$15,805 award has been included only once in the totals.</u>

This procedure can exclude some awards that are not duplicative. For example, if an organization did not submit a report in the current quarter it would be excluded. Given the inconsistencies with award numbers, it is difficult to tell whether an award was reported in the current quarter under a slightly different award number or simply not reported. The above error protocol attempts to filter out errors, but the reporting system ultimately depends on the organizations reporting the information and the federal agencies reviewing such information to ensure accuracy.
